We are the All-Ukrainian Public Association “National Assembly of People with Disabilities of Ukraine” (NAPD).

The NAPD is an umbrella association of 122 national and regional public organizations of people with disabilities, including those created and led by people with disabilities, legal representatives of people with disabilities, and parents raising children with disabilities. Their activities are spread at the national and local levels in different regions of Ukraine.

The NAPD is an influential and powerful organization taking an active part in the formation and implementation of state policy in the field of the rights of people with disabilities. We are an active participant in advocacy processes aimed at protecting the rights of people with disabilities, as well as ensuring their participation in the country's recovery and rapid humanitarian response.

We are part of the international public movement of people with disabilities and members of the European Disability Forum.

We collaborate with international organizations, UN agencies, the UNHCR humanitarian cluster coordination system, and humanitarian organizations to advocate for the rights of people with disabilities in recovery and rapid humanitarian response.

NAPD-2024: Year's Results and Steps Forward

2024 was a year of significant challenges and achievements for the National Assembly of People with Disabilities of Ukraine (NAPD).

We have been working tirelessly to advocate for the rights and support of the most vulnerable Ukrainians: people with disabilities, families who care for children and adults with disabilities, and elderly people.

In August in Geneva, at a meeting of the UN Committee on the Rights of Persons with Disabilities, the Ukrainian civil society delegation, which included representatives of the NAPD, presented an alternative report on the situation of the rights of persons with disabilities during the war. Violations of rights, problems of evacuation, access to medical, social and humanitarian services, difficulties in education and employment, as well as the particular vulnerability of women and girls with disabilities were discussed. Based on the official report of the State, the alternative report of civil society organisations and the conclusions of international institutions, the Committee adopted the Concluding Observations on the combined second and third periodic reports of Ukraine.

The war caused a lot of suffering to people in all regions of the country. That is why NAPD promptly responded to challenges and provided assistance to those in need.

We were actively involved in legislative initiatives aimed at improving the social protection system, employment and employment, reforming the Medical and Expert Social Commissions (MSEC), and expanding opportunities for people with disabilities.

Throughout the year, we organized educational events, training sessions and advocacy campaigns, strengthened the capacity of local organizations of people with disabilities, and helped them to influence decision-making in the country's recovery process at the regional level.

We continued to defend the rights of people with disabilities and their families: provided legal advice, informed about current legislation, taught them to defend their rights and guarantees, to take an active part in community life, and become leaders.

Thanks to the support of international partners, we have implemented a number of humanitarian projects that have allowed us to expand our assistance and make it more systematic. The main areas of support include: provision of food, hygiene products, assistive technologies, financial assistance, protection; organization of access to medical and rehabilitation services; transport services, as well as psychological and legal support.

NAPD-2024: Year's Results and Steps Forward

NAPD has approved a new Strategy of Activities for 2024-2028

"Together We Are Changing the Lives of People with Disabilities for Better!" The organizational development and institutional support of the NAPD members and partner organizations are defined as one of the strategic areas of activity.

Throughout the year we organized educational events, trainings, and advocacy campaigns, strengthened the capacity of local organizations of people with disabilities, and helped them influence decision-making in the processes of recovery of the country at the regional level.

We continued to protect the rights of people with disabilities and their families: provided legal advice, informed about current legislation, and taught them to defend their rights and guarantees, take an active part in the life of community, and become leaders.

During the year, the NAIU signed 23 memoranda of cooperation with communities, which aims to combine efforts in the field of training, employment and hiring of people with disabilities, social adaptation, dissemination of inclusion policies, as well as improving the accessibility and quality of medical and rehabilitation services in medical facilities.

A landmark event of the year was the opening of the Inclusive Disability Hub – a platform for sharing knowledge and experience in the field of inclusion.

We will continue working to ensure that people with disabilities have equal opportunities, decent living conditions, and access to all necessary services.

This report summarizes our activities in 2024, analyses key achievements and challenges, and identifies next steps in the fight for equal opportunities for all.

The NAPD expresses its sincere gratitude to everyone who joined our common cause: international partners, donors, public organizations, and concerned citizens. Together we are changing the country!

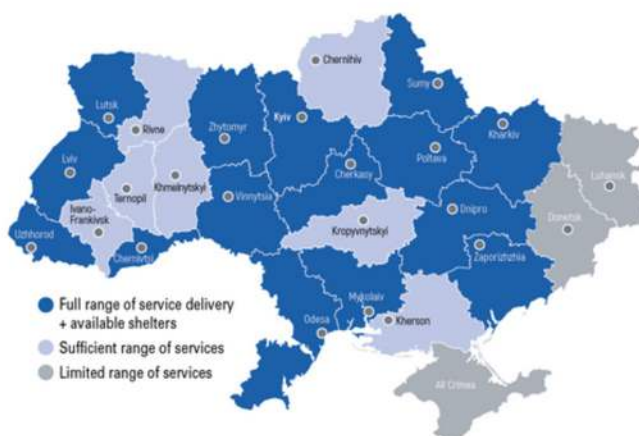

Improve the life conditions and access to inclusive humanitarian assistance regarding nutrition, livelihoods, protection, and healthcare.

Project achievements



- **Analysis of the situation** regarding the project target group in the pilot communities (persons with disabilities (women, men, children), people 60+, IDPs, persons with the status of combatants since February 24, 2024), including quantitative indicators; services, transport logistics, availability of medical facilities, and other support



- **4,027 people received financial (cash) assistance**



- **321 people received assistive technologies and wheelchairs**

- **892 transportation services provided, including delivery to medical and social protection facilities** (social taxi for the project target group)

- **2,789 people received the needed information on mental health and first psycho-social aid**

- Social workers were supported by procuring bicycles for them



Project achievements



- **Enhanced capacity of NAPD member and partner organisations** through training in inclusive humanitarian response, security, and first medical and psycho-social aid.
- **Large-scale two-stage advocacy campaign** “Inclusive Communities: United Actions to Protect the Rights of People with Disabilities with Their Active Participation”



- **Research** into the psycho-emotional state of population with low mobility in the communities of Volyn, Poltava, and Chernivtsi regions
- **Guidelines** on mental health, assistive technologies, and rehabilitation for medical facilities and end users



- **Internal monitoring** of the satisfaction among the project target group with major project activities – 97% respondents gave a high rating, confirmed with survey results





Project achievements

Disability training and awareness-raising events:



- **Training for community coordinators** “Inclusive Humanitarian Assistance” and webinars in humanitarian response, communications in a team, communications with media, and other themes



- **Training for doctors of medical facilities,** delivering assistance to veterans and their families, in pilot communities to prevent burnout



- **Training for doctors in pilot communities** “Overcoming Mental Health Gaps in Communities
- **More than 50 information** materials, articles, and posts in Ukrainian and English published in social media to highlight key project activities

- improve the access of people with disabilities to high-quality medical services in the selected territorial communities in six partner regions – Zakarpattia, Lviv, Poltava, Zhytomyr, Odesa, and Volyn;
- enhance the capacity of the selected local organizations of people with disabilities within public advocacy to remove identified medical inclusion gaps.

Project achievements



- **Methodology developed** for assessing the accessibility to rehabilitation services



- **Research conducted** (public opinion, interviews with local government officials, heads of medical facilities, and in-depth interviews with medical facilities' staff), including audits of informational, digital, transport, and architectural accessibility



- **Analytical result-based report prepared** and presented to the communities

- **Architectural accessibility** audit of medical facilities conducted



Project achievements



- **More than 300,000 people**, including **25,200 individuals with disabilities**, who reside in 8 communities, will have a possibility (if necessary) to:

- receive rehabilitation services through modern equipment, accelerating their recovery;
- receive administrative services online



- **22 units** of rehabilitation equipment purchased for rehabilitation departments and centers

- 276 units of assistive technologies granted for assistive technology rooms

- **12 all-in-one computers and 12 printers** purchased for communities to create working places for individuals with disabilities



- **48 informational stands in Braille** created to enhance the accessibility of medical facilities





Project achievements



Specialists from various fields have united their efforts to provide comprehensive assistance to people with disabilities:

510 local governments, medical facilities, and public organizations of people with disabilities have gained new knowledge and skills, enabling them to provide assistance to their patients more efficiently



49 events involving representatives of local governments, medical facilities, and public organizations of people with disabilities

20 memoranda of cooperation between NAPD and local governments and medical facilities



Public organizations have received support for their activities, which enables them to protect the rights of people with disabilities more efficiently:

13 public organizations of people with disabilities.

2 webinars on advocacy at the local level.

To ensure persons with disabilities and their representative organisations (OPDs) are included in the response and recovery of the Ukrainian war

Project achievements



Rapid response and humanitarian support for vulnerable groups of population in various regions of Ukraine and public organizations of people with disabilities:

- More than 6000 people with disabilities, their family members, and representatives of organizations of people with disabilities used the project services in different regions of Ukraine: humanitarian assistance, legal consultations and support, psychological consultations, informational support for people with disabilities, the elderly; strengthening the capacity of public organizations of people with disabilities through micro-grant programs; improving access to medical services for residents of 6 communities, including people with disabilities, and other groups.
- More than 3000 women/men with disabilities, families raising children with disabilities and providing them with care received legal assistance, counseling on social and legal issues, psychological support, etc.
- More than 1000 people/children with disabilities from different regions of Ukraine received multi-purpose financial assistance, supportive rehabilitation equipment, and assistive technologies.





Project achievements



6 communities were supported to improve access to medical services for community residents, including individuals with disabilities:

- Over **100 pieces of equipment** were purchased for **8 healthcare facilities**,
- **Accessible gynecological clinics** for women, including those with disabilities, were created in 3 communities;
- **2 paramedic and obstetric stations** were **repaired** in Opishnia and Karlivka communities of Poltava region, with regard to accessibility for people with disabilities.

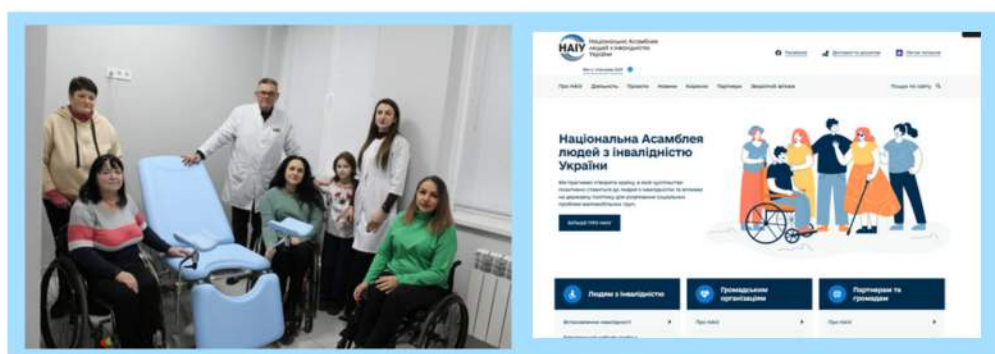


Supported institutional and organizational capacity of **14 organizations** of people with disabilities - members of NAPD, which successfully implemented microgrant projects in the regions and participated in initial trainings and seminars.



Thanks to the project support, the organizational capacity of the NAPD has been strengthened:

- NAPD’s policies and charter documents were reviewed and updated;
- NAPD’s Activity Strategy for 2025-2028 was developed and approved;
- new website was launched, and other activities.





Project achievements

Advocacy activities at the national and international levels:



- preparation of materials for alternative report of the UN Committee on the rights of people with disabilities and further advocacy of the Concluding remarks on the the combined second and third regular reports of Ukraine on the implementation of the UN CRPD;



- an online survey was conducted to determine readiness for the autumn-winter period of 2024-2025, and an Analytical report was presented;



- methodological recommendations on accessibility-related issues were prepared, and other activities.

Goal:

Enhance the capacity of organizations of people with disabilities in decision-making processes and creating an accessible environment, fostering an efficient usage of inclusive practices and ensuring equal opportunities for all citizens, including people with disabilities, in all aspects of social, economic, and cultural life

Project achievements



- 2 webinars were conducted for organisations of people with disabilities on accessibility issues: 309 people improved their knowledge of creating an accessible environment.
- A discussion panel was held to identify the needs of people with disabilities in Mykolaiv region: 39 people (representatives of about 20 OPDs of different disabilities) participated.



- Promoting physical accessibility of two medical facilities in Mykolaiv: 2 healthcare facilities were inspected, resulting in the procurement of adjustable examination couches were purchased and installment of a ramp and a lift for people with limited mobility.



- Psychological support for opinion leaders, activists, and representatives of local organisations of people with disabilities: 23 people - leaders and activists of 10 public organisations of people with disabilities of different nosologies from Mykolaiv region and Mykolaiv city – took part in the psychological and social training.
- Provision of legal advice and information support to people with disabilities and the 60+ age group: 64 people with disabilities received consultations, resolved issues related to restoration of documents, provision of rehabilitation aids, support in applying for pension and other social benefits, protection of rights guaranteed to people with disabilities, etc.



Project achievements

- **Carrying out an advocacy campaign on accessibility of medical facilities in Mykolaiv region:**



A memorandum of cooperation was signed with the municipal Mykolaiv City Ambulance Hospital of Medical Care and Mykolaiv Primary Health Care Centre No. 3;



An accessibility audit of the two hospitals was conducted using the questionnaire designed by NAPD experts. Based on the audit results, reports were prepared containing recommendations for improving accessibility of hospitals and medical services.

- Improve living conditions and access to inclusive humanitarian assistance in the areas of nutrition, livelihoods, protection, and health.

Project achievements



- **Improving access to rehabilitation services** in pilot regions (Vinnytsia, Dnipropetrovsk, Zhytomyr, Kyiv, Lviv, Kharkiv, Chernivtsi regions, and Kyiv city), which allowed to significantly increase the number of people with access to quality medical and social care.



- **Provision of case management to 569 people with disabilities**, which provided support in solving legal, social, and medical issues, and helped improve their quality of life.



- **Information and awareness raising activities: 19 webinars and trainings** were held for representatives of civil society organisations to help increase the efficiency of such organisations in providing qualified humanitarian assistance and responding to the needs of individuals.





Project achievements



- **Providing humanitarian assistance for almost 2,500 people**, including individuals with disabilities, elderly people, and other vulnerable groups of population. The assistance included hygienic products, food kits and vouchers, transportation and temporary accommodation.



- **Delivering legal aid:** 550 people received social and legal consultations via the Hotline.



- **Raising the awareness through information provision: more than 300,000 people** were reached by online meetings, seminars, and awareness-raising campaigns through the web-site and social networks aimed at enhancing the knowledge about the rights of people with disabilities, access to services, and regulatory acts on social support.

Project achievements



- Two discussion panels “Challenges of Access of People with Disabilities and the Elderly to Humanitarian Response Activities” aimed at updating the agenda of existing problems of people with disabilities in the humanitarian sphere.



- **Forum “Inclusive Humanitarian Response: the Voices of People with Disabilities”** was conducted to identify the problems of people with disabilities in the humanitarian response.



- The Forum recommendations on mainstreaming disability in humanitarian response in 2025 were prepared and advocated.
- The Concluding Remarks of the UN Committee on the Rights of Persons with Disabilities have been translated and advocated regarding the combined 2nd and 3rd regular reports of Ukraine on the implementation of the UN Convention on the Rights of Persons with Disabilities.





Project achievements



- **Camp for leaders of organisations of persons with disabilities** - members and partners of the NAPD – on advocacy of the rights of persons with disabilities in humanitarian response was held in Lviv region.



- **Guidelines on ensuring the rights of persons with disabilities in humanitarian response** and recovery in the context of Article 11 of the UN Convention on the Rights of Persons with Disabilities were prepared.



- Active participation in the work of the Health, Food, Security and Livelihoods, Protection, and Shelter clusters, as well as Age and Disability; Housing; and Land and Property Working Groups, as well as international and national organisations working in the humanitarian sphere to ensure that disability is mainstreamed into humanitarian response.

- Provision of people with disabilities with social and legal consultations, financial assistance, hygienic kits, and assistive technologies

Project achievements



Provision of financial assistance and assistive technologies

to nearly 200 people with disabilities.



Provision of social and legal assistance: 213 consultations were provided, resulting in the renewal of documents, transfer of benefits, obtaining assistive technologies from authorities, and other forms of support.



Provision of humanitarian assistance: 717 individuals with disabilities received personal hygiene kits.

Training on advocacy for the rights of persons with disabilities in humanitarian response was conducted for 35 trainers.

Raising awareness through information: over 100,000 people were reached through online meetings and an information and awareness campaign via the website and social media, aimed at raising awareness of the rights of persons with disabilities and relevant regulatory and legal acts in the field of social support.

Goal:

Improve the quality of life for children and youth with disabilities by providing them with the necessary technical means, particularly with smart watches.

Project achievements



- A qualitative collection and processing of needs of children and youth with disabilities was conducted. This information was used to determine the parameters when procuring smartwatches.
- **88 children and youth with disabilities received support in the form of smart watches in 13 regions of Ukraine.**
- These devices will not only become convenient assistants in everyday life, but will also provide additional security and communication possibilities during emergencies.

The National Assembly of People with Disabilities of Ukraine took part in the 31st Session of the UN Committee on the Rights of Persons with Disabilities

The 31st session of the UN Committee on the Rights of Persons with Disabilities took place in Geneva from August 12 to September 5, 2024. The Ukrainian civil society delegation, including representatives from the National Assembly of People with Disabilities of Ukraine (NAPD), the Ukrainian Society of the Deaf, the Ukrainian Society of the Blind, the Fight For Right organization, and the League of the Strong, presented the Committee with the latest information on the situation of the rights of persons with disabilities in Ukraine during the war.

The report, based on the standards of the UN Convention on the Rights of Persons with Disabilities, covered the period following Russia's full-scale invasion in February 2022. It highlights the situation of people with disabilities, along with the challenges and needs they are facing during these difficult times.

During a closed briefing, the Ukrainian delegation discussed key issues with the Committee members, including systematic violations of the rights of persons with disabilities in the context of the war. Particular attention was given to the difficulties faced by persons with disabilities during evacuation, access to medical care, humanitarian support, social services, as well as challenges in education and employment. Particular emphasis was placed on the violations of the rights of women and girls with disabilities, who remain especially vulnerable in the context of armed conflict.

Based on the results of the session, the Committee provided its **Concluding Observations to the State** party regarding the implementation of the UN Convention on the Rights of Persons with Disabilities.

The Forum resulted in the development of Recommendations for mainstreaming disability issues in humanitarian response in 2025. This document includes an analysis of the current situation regarding the needs of people with disabilities and the elderly during wartime, across various spheres of life. It also offers specific recommendations on how to ensure cross-cutting inclusiveness of humanitarian response in the coming year.

The Forum Recommendations were developed taking into account the views and proposals expressed by people with disabilities, elderly individuals, organizations representing them, parents raising children and youth with disabilities, veterans and their family members, women who have returned from captivity, and affected civilians who participated in the Forum.

Advocacy in Action

Legal Aid Hotline for People with Disabilities and the Elderly (NAPD Hotline)

In 2024, the National Assembly of People with Disabilities of Ukraine (NAPWD) continued to provide legal support to people with disabilities and the elderly, ensuring access to qualified advice and the protection of their rights.

Throughout the year, the NAPD Hotline received **3,034 calls** from various regions of Ukraine. The most common inquiries were related to:

- obtaining and renewing disability,
- access to social benefits,
- mobilisation of incapacitated persons,
- protection of labour rights,
- receiving humanitarian aid,
- access to free rehabilitation services.

NAPD experts provided legal advice and assisted in drafting appeals to state authorities. Significant attention was given to issues related to the reform of medical and social expert commissions, legal support for individuals affected by the war, and the protection of the rights of those in urgent need of social security.

In 2025, NAPD will continue to expand its legal aid capabilities, ensuring even more timely and high-quality protection of the rights of people with disabilities and the elderly. Plans include enhancing information support, developing partnerships with human rights organisations, and improving response mechanisms to address requests more effectively.



Advocacy in Action

Military Registration of People with Disabilities

From the very outbreak of the full-scale invasion, the National Assembly of Persons with Disabilities of Ukraine has been deeply committed to protecting the rights of people with disabilities and their families. Key initiatives include:

- Exemption from military mobilisation for persons with disabilities;
- Granting of deferrals to individuals who provide care for persons with disabilities;
- The ability for persons with disabilities liable for military service to apply for deferment online;
- Automatic extension of deferment for individuals with disabilities who are liable for military service;
- Exemption from medical examinations for persons with disabilities liable for military service, including those previously classified as “limited fitness”;
- Possibility for Military and Medical Commissions to make decisions regarding individuals with disabilities aged 17-24 based on disability documentation and/or databases, rather than requiring physical examinations.

This is not an exhaustive list of the initiatives advocated by the National Assembly of People with Disabilities and successfully implemented.

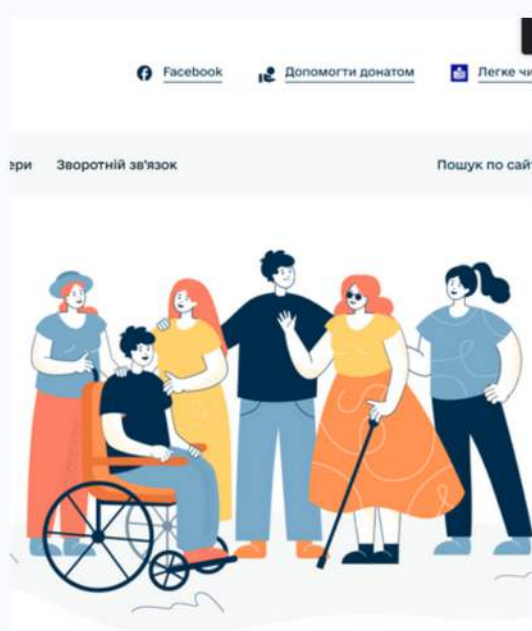
